15 INITIAL INCIDENT DESCRIPTION / NARRATIVE:

[\*\*\*ICV/BWV Activated \*\*\*]

The following occurred in the City of Seattle, County of King, within the State of Washington. On October 2, 2018, I was working uniform patrol for the Seattle Police Department, in the City of Seattle. I was in full uniform, driving a fully marked patrol vehicle equipped with emergency lights and siren. I am currently assigned to patrol operations in William Sector, a district of the Southwest Precinct. On the afore mentioned date, I was working as assigned patrol unit 1-William -1. At approximately 1119 hours the 911 Communications Section received a call reporting a fight.

The call read as follows, " 3 MALES IN PHYSICAL WITH ONE OTHER MALE, NO WEAPONS"

While en route to the call the call, update read as follows, "M) ANOTHER REPORTING AN ADULT MALE IN A PHYS FIGHT WITH 3 TEENS, NO WPNS SEEN.

I arrived at California AV SW & SW Admiral WY SW. When I arrived on scene in front of the Wells Fargo, I was approached by Suspect/[REDACTED] who was later identified by his ID. When I arrived, he was yelling that he was assaulted and he had a head injury to his head with blood coming down his face. S/[REDACTED] yelled at me several times for me to get his back pack back. I thought that this was strange behavior after someone has just been struck in the head with blood coming from his head. S/[REDACTED] stated that he walked up to V/[REDACTED] and confronted him because V/[REDACTED] was talking crazy to his little bro. I asked him what was V/[REDACTED] saying to his little bro. S/[REDACTED] stated that he heard V/[REDACTED] say get back. S/[REDACTED] stated that he heard V/[REDACTED] say that if they didn't get back they would be shot. I asked S/[REDACTED] what is the name of his little bro, and S/[REDACTED] stated he didn't want to give his name. I thought that this was strange that he did not want to provide his brother's name if they all were assaulted.

I walked over to Victim/[REDACTED] ([REDACTED]/1969) who was standing and yelling that he was assaulted. Sus/[REDACTED] stated that V/[REDACTED] had a gun. V/[REDACTED] was compliant and I removed the gun from the back of his right rear pants pocket. I secured the gun on my person. V/[REDACTED] possesses a current concealed pistol license.

V/[REDACTED] stated that he was at the Wells Fargo ATM depositing money, and was approached by several males. V/[REDACTED] stated that one of the males asked him to hurry up. V/[REDACTED] told the males to back up. V/[REDACTED] stated that an unidentified white male wearing a red hoodie with red curly long hair bear hugged him from behind, lifted him up and slammed V/[REDACTED] on the ground. The male was later identified as Suspect/[REDACTED], ([REDACTED]) who attends West Seattle High School.

V/[REDACTED] stated that S/[REDACTED], S/[REDACTED] and another BM identified later as S/[REDACTED], [REDACTED] (1990/1992) began striking him multiple times all over his body with their fists while V/[REDACTED] was lying with his back on the ground. V/[REDACTED] told the males repeatedly to stop and leave him alone, but the males did not. V/[REDACTED]'s glasses were knocked off along with his hat. V/[REDACTED] did not say anything was taken from his person or taken from him.

V/[REDACTED] stated that he grabbed a rock that was nearby, while he was on the ground and hit S/[REDACTED] in the head with a rock to get the males away. V/[REDACTED] stated that he managed to get to his feet. He was swinging at others but was unsure if he hit them. He then told the males that he was going to his car to get his gun, because the males would not stop assaulting him. The males continued to advance on him. V/[REDACTED] then went to his vehicle and grabbed his firearm, raised it in the air and yelled at the males to leave him alone. V/[REDACTED] then placed the handgun into his rear pocket. S/[REDACTED] walked away. S/[REDACTED] remained on scene as V/[REDACTED] had his wallet and backpack. V/[REDACTED] told me the reason that he kept the items was so that S/[REDACTED] would stay on scene as he yelled at them "you all are going to jail" S/[REDACTED] was not on scene and was not located.

There were no witnesses that directly observed the event on scene that I could locate. I talked to the manager at Wells Fargo identified as Witness/[REDACTED] (1990/1992). W/[REDACTED] stated that he observed S/[REDACTED] and V/[REDACTED] arguing and he called 911 also. I asked if there was surveillance in the area, and he said there is and would provide it later because it takes a few days to obtain.

Seattle Fire Responded to the scene and treated S/[REDACTED]. S/[REDACTED] was transported to Harborview for further medical treatment.

Officer Perrotti followed AMR to Harborview and sat with S/[REDACTED] until the investigation was finished. Officer Daily 8407 replaced Officer Perrotti at the hospital.

V/[REDACTED] provided me with a statement that was captured on my Seattle Police Department issued voice recorder and uploaded to DEMS. V/[REDACTED] signed a sworn affirmation statement form. I photographed his injuries and uploaded to DEMS.

Seattle Fire treated V/[REDACTED] on scene. He had minor scratches and on his left and right elbow indicating that he was on the ground. V/[REDACTED] also had scratches on both knuckles and on his hands. I observed blood on his shirt and pants. While speaking to V/[REDACTED] he complained of moderate back pain and pain to his side.

Sub/[REDACTED], [REDACTED] who is the Principal at West Seattle Hight ([REDACTED])

arrived on scene. Sub/[REDACTED] stated that a male later identified as Sus/[REDACTED] arrived back at school with an injured hand and scratch to his neck as well as Sus/[REDACTED]. Sub/[REDACTED] asked for the descriptions of the males involved to see if they were the ones involved. I later went to the school and asked the Principal to have S/[REDACTED] and S/[REDACTED] come to the Office. S/[REDACTED] was not at the school and was scheduled to be in school. S/[REDACTED] was brought to the Office.

S/[REDACTED] had cuts to his lower neck area and several cuts to both hands. He was treated by the nurse when he arrived back at school. His right hand was bandaged up. Officer Constantin 8379 advised S/[REDACTED] of Miranda before speaking to him. He did not invoke his rights, and spoke to us.

I asked S/[REDACTED] what occurred and he stated that they were standing at the Wells Fargo ATM and asked how V/[REDACTED] was doing as they were standing at the ATM. S/[REDACTED] stated that V/[REDACTED] struct his friend first because V/[REDACTED] thought his friends were trying to steal money from him

This contradicted what I was told by S/[REDACTED] earlier that V/[REDACTED] was talking crazy to his "little bro" V/[REDACTED] stated he was at the cash machine withdrawing money from the machine, and then approached from behind by the three males. The three males were not standing at the atm machine before V/[REDACTED] was there. There appears to be discrepancy of what occurred.

S/[REDACTED] stated that V/[REDACTED] continued to get into the face of his friends, and took his friends backpack. S/[REDACTED] stated that after he heard V/[REDACTED] say he was going to get his gun he walked off.

S/[REDACTED] stated that V/[REDACTED] grabbed a rock and hit S/[REDACTED]. Officer Constantin 8379 took a recorded audio statement from S/[REDACTED] and photographed his injuries.

I screened the incident with YSC and they declined to take S/[REDACTED] and S/[REDACTED]. I screened the incident with A/SGT Bale 6783. I Interviewed and released S/[REDACTED] at West Seattle High. S/[REDACTED] was interviewed and released from Harborview Medical Center.

S/[REDACTED] declined to give a statement. V/[REDACTED] positively identified S/[REDACTED] through a field show up by Officer Eby 8498 at West Seattle High School.

S/[REDACTED] & S/[REDACTED] was provided with a business card with an incident number. V/[REDACTED] was provided with a business card with an incident number. I provided Sub/[REDACTED] with a business card with an incident number.
