Geotechnical work near you

Nighttime Soil Sampling

Starting as early as **October 8, 2019,** Sound Transit will begin drilling to collect soil samples for analysis at **Harbor Marina Corporate Center (Terminal 102)**; see reverse side for boring locations and estimated timeline. This work will inform planning of the West Seattle and Ballard Link Extensions Project.

What to expect

- Work at Terminal 102 will occur during nights, from 6:00 pm – 7:00 am.
- Each boring will take approximately 5-7 days and will be filled and patched with a flushmounted monument surface when work is complete.
- The borings will be located in parking lots and/or driveways.
- At least 72 hours prior to each boring, Sound Transit will notify the Port of Seattle, Northwest Seaport Alliance and impacted tenants; where necessary, "no parking" signs will be placed near impacted parking spots.
- Expect cones, signs and traffic control to direct traffic around drilling equipment and trucks in the area. Temporary parking restrictions and pedestrian detours will be in place as needed.
- Drilling equipment will sound similar to a truck engine running with intermittent hammering noise.

Drilling at each location is anticipated to last approximately 5-7 days. Work will occur during nights, from 6:00 pm – 7:00 am. The anticipated start dates are tentative and subject to change. At least 72 hours prior to each boring, Sound Transit will notify the Port of Seattle, Northwest Seaport Alliance and impacted tenants.
