

NOTICE OF EMERGENCY WORK

April 24, 2020

SEWER PIPE REPAIR IN YOUR NEIGHBORHOOD

PROJECT DESCRIPTION

Starting on April 27, Seattle Public Utilities (SPU) is performing an emergency sewer pipe repair near your home.

LOCATION

Work will occur in the alley between 36th and 37th Ave SW and SW Stevens St and SW Hanford St. See approximate locations for the two phases of work in the included map.

SCHEDULE

Emergency work is expected to begin on Monday, April 27 and it will take about 6-8 weeks to perform this work. Typical work hours will be Monday through Friday from 7:00 a.m. to 5:00 p.m. Weather and other factors may impact the start date, working hours, and duration of work.

ANTICIPATED IMPACTS

Residents and businesses will continue to receive normal services during construction. However, you can expect:

- Increased construction traffic and staging of large equipment in the area
- Pavement excavation, noise, dirt, and vibrations
- Restrictions to alley access and parking garages near active work areas
 - During the initial phase of work, the contractor will be working on the south side of the alley near SW Hanford St. Access to the alley from the south side will be closed 24-hr a day for about 1-2 weeks.
 - The next phases of work will take place further north in the alley. When possible, the contractor will reopen the alley and garage access during non-work hours
 - Please pay attention to on-site signage and relocate your car outside of the work area if you need access.
- Residents adjacent to the repair may be asked to limit water usage. Contractor crews will provide notification when performing work that will require reduced flow.
- The contractor will perform pavement restoration following repairs.

CONSTRUCTION UPDATE REGARDING COVID-19
