# Notice of upcoming construction

Starting as soon as November 22, crews will set up traffic control to begin construction at the southwest corner of the 20th Avenue SW and SW Roxbury Street intersection. Work will include demolishing the existing pavement, paving the roadway, and making improvements that will serve Routes 113, 120 (future RapidRide H Line), and 560. This work is expected to last through late February 2022.

### During this work:

- Sidewalk and traffic lane closures will be in place
- Detours will be in place for people driving, walking, and rolling
- Access to driveways and businesses will be maintained
- This work will impact Metro Routes 113 and 120, and Sound Transit Route 560

### What to expect

- ▶ Typical construction hours are weekdays, 7 a.m. to 3:30 p.m., with occasional weekend and night work
- ▶ Temporary sidewalk closures. Detours will be in place for people walking and rolling
- ▶ Temporary intersection closures. Detours will be in place for people driving
- ▶ Temporary lane closures. Crews will direct traffic around the work area
- ▶ Detours and temporary stop relocations for Route 120
- ▶ Loud noise and vibrations
- ▶ Dust and debris

### Project background

King County Metro, in partnership with Seattle Department of Transportation and the City of Burien, is upgrading Metro Bus Route 120 to RapidRide H Line. Construction began in June 2021 and will be ongoing into 2022. Starting in 2022, RapidRide H Line will connect Burien and White Center to Downtown Seattle/South Lake Union through the Delridge neighborhood. This new RapidRide H Line route will improve travel times, reliability, and connections to other buses and Link light rail.
